It has been several years since this association has held a neighborhood-wide annual meeting. Eaglewood has seen a healthy turnover from some of its original homeowners, to the “next generation” of new families over the past 18 to 24 months. The influx of new homeowners choosing to live in Eaglewood with young families, presents an opportunity to become involved in the Eaglewood HOA.

Currently, the HOA is operating without an elected President, as our previous President recently moved out of Eaglewood. The remaining officers have held the positions of Treasurer and Secretary for over ten years. There is a feeling among the current officers and trustees that the Association needs a refresh, so to speak. The current trustees believe it is time to elect new officers and trustees, in order to ensure the Eaglewood subdivision continues to be maintained in accordance with the Eaglewood HOA Code of Regulations. In addition to required administrative functions, officers and trustees would be able to bring fresh ideas on organizing and planning neighborhood recreational activities and events.

The current trustees are happy to stay on the HOA Board during transition to new officers for the next couple of years. The time requirement is minimal. The estimated hours of commitment for President, Treasurer and Secretary- has been approximately ten to twenty hours each per year to conduct meetings, collection of annual dues and book keeping for HOA expenses. The average time commitment for trustees is even less.

The meeting agenda will focus on the election of Trustees (2 to 7). (Trustees then elect officers.)
